



Our approach

Our research and evaluation principles

We will always put people, not data, at the heart of our evaluation design.

- We establish a clear purpose which is directly relevant to the audience – working closely with our clients to identify their priority purpose and audience.
- Our style is human and engaging, avoiding abstract technical jargon. We co-design evaluation approaches according to your need and the busy, complex world of health and care.
- We combine different ways to learn and contribute, collaborating with the broadest range of stakeholders and using innovative techniques to build consensus around priorities.
- We encourage difference of opinion, foster openness through learning and harness diverse groups for problem solving.
- We respect participants' time – no-one has time to spare; our approach delivers evidence in an efficient way.
- We balance rigour with practicality ensuring that our measurement solutions maximise efficiency whilst remaining credible to the target audiences.
- We ignore arbitrary distinctions between measures for research, improvement, evaluation and management. Instead we focus on ensuring that metrics are used to foster reflection, drive evidence based decision-making and assess impact.
- We produce resources which will last – creating a suite of useful insights, communicated in the best way to catalyse learning and development.



Our experience

Our research and evaluation work combines traditional and innovative methodologies with Kaleidoscope's expertise in delivering insights and formative learning. We have supported a range of impact measurement initiatives for Public Health England, NIHR, Versus Arthritis, British Red Cross, UCL, Helpforce, Guys and St Thomas' Charity, National Children and Young People's Diabetes Network, Bill & Melinda Gates Foundation, as well as CCGs and STPs, among many others.

Examples

- **Versus Arthritis: a mixed methods evaluation of the MSK Champions Programme** – measuring change in leadership and professional networks for musculoskeletal care and assessing contribution to health service delivery outcomes. We combined case studies, key informant interviews, online surveys and social network analyses to articulate the programme's effectiveness, strategic relevance, and attribute improvements in care at the midpoint.
- **ImproveCareNow: learning network support** – co-developing a dashboard to review progress across over 100 participating member care centres and six workstreams. We engaged leaders to prioritise metrics and worked with data analysts to develop a monthly dashboard of control charts to visualise data trends and highlight special cause variation.
- **Public Health England: evaluation design and shared learning** – supporting the evaluation and dissemination of the Prevention Concordat for Better Mental Health. We researched best practice in delivering local change from national policy, undertook a stakeholder survey, and designed a formative evaluation including a theory of change and measurement framework to support local authorities to improve public mental health. We also produced a range of communication products, running 20 events to support the document's dissemination and shared learning following publication.
- **Cambridgeshire and Peterborough STP: developing digital pathways for diabetes** – a pathways and performance analysis of diabetes care and scoping of the role of Primary Care Networks in digital interventions. We conducted surveys among patients, practices and PCNs to map out challenges and opportunities for digital solutions for diabetes care. A process map and interactive dashboards highlighted gaps and opportunities for digital interventions.



- **Helpforce: learning network support** – to engage 13 NHS Trusts and other partner organisations in reviewing their experience with HelpForce and co-designing a learning network. We trained the Helpforce team in gathering, processing and analysis of outcomes data, knowledge translation, the management of a multidisciplinary network and the creation of a community that learns from participant experience.

- **Measurement prioritisation and dashboard development.** Transforming quantitative measures into beautiful and meaningful dashboards to tell your data story at-a-glance and track progress over time.
